
Director's Note

Welcome to 2009, and what a year it promises to be! I just got back from the **Inauguration** in DC because I'll tell you, if I didn't see it with my own eyes, I'd probably still be wondering if it was one huge dream. And while we, of course, don't want to express any political affiliations, I do want to point out some of the ways the incoming administration has laid out tangible policies that will positively impact LGBT people, and therefore LGBT disparities nationwide. First, I know not everyone realizes that in most states it's legal to fire people just for being LGBT, but unfortunately that is true. So we were heartened to see an early stand against discrimination when the Obama transition team announced they would not discriminate



against LGBT people in their consideration of incoming appointees. Then a further amazing step was publishing an historic 8-point LGBT civil rights platform on his transition website, which included support to pass a **non-discrimination law** nationwide. Yes indeed, change is starting at the top, and we are really looking forward to how that might impact all of our work over the coming years. So, as 2009 starts out on a big wave of hope for so many, it's speeding right from there into **Creating Change!** Yup, if you don't know, Creating Change is the largest LGBT leadership conference nationwide, and right now over 2,000 amazing people are flying to Denver to join in learning and planning strategies to make a difference in 2009. Tomorrow (at 4 am!) I'm flying out to Creating Change to do our usual shtick, which is roughly stand anywhere I can and beg folk to think about how they can expand their focus to include tobacco. Alright, not exactly begging, apparently I'm presenting at 5 or so workshops, but it's all the same point – come on, think about how you can start working on tobacco too!

But wait, the most important news we have is... thanks to our valiant new co-chairs, **Loretta Worthington, Sunshine**, and **Blue** (rock on all the one name folks) planning has already started for the **2009 LGBTQ Tobacco Control Summit**. Remember it's already an **ancillary meeting for the next National Conference on Tobacco or Health**, so plan on coming to **Phoenix on June 9th**, for the next summit!

News From the Network

In December **Lisa Harrison** participated in a meeting with the **National Latino Tobacco Control Network at the Latino Commission** on Aids in New York City. We discussed the overlap between the Latino LGBT community and how the LGBT TCN can build better bridges in this community. One area that was raised as a concern was the lack of data in the **Transgender Latino** community. One way to respond to this need was to encourage people to take the **National Gay and Lesbian Task Force Trans Health Survey** which includes questions about tobacco use. The specific tobacco questions are 51-53 of this survey. Please disseminate this survey widely. We will keep you posted with the results and stay tuned for some upcoming collaborative work with the Latino advocates!

It's also been an exciting month for the **Leave No Funds Behind** Project. We successfully completed our three part **webinar series** in which over 40 participants in 20 states joined in to hear about the \$100,000 funding opportunity through the **American Legacy Foundation**. We heard many innovative ideas and are thrilled that LGBT organizations are passionate about tackling tobacco health disparities. We'd love to replicate this series for other funding opportunities, so if you hear of any in your state or nationally let us know!

Scout also did some stuff since our last newsletter, including presenting on LGBT data collection at the fall **National Coalition for LGBT Health** meeting; presenting on a few things at the **American Public Health Association** conference; giving a plenary at the **Gay and Lesbian Medical Association** conference; but that's old news now. Wait though, we also participated in a super rare Parity Alliance meeting in D.C. in December. The **Parity Alliance** is a group of Community of Color and LGBT leaders working to advance tobacco disparity work nationally. Watch for work coming out of that really cool planning session, and thanks to the **Asian American Pacific Islander network, APPEAL**, for spearheading that gathering.


